C. Kralt & zonen B.V. processes your personal data because you use our services and/ or because you provide this information to us.

For what purpose and on what basis we process personal data

- Handling your orders and payment

- We can call or e-mail if necessary to carry out our services
- To inform you about changes in our services and products
- C. Kralt & zonen B.V. also processes personal data if we are required by law to use the information we have is necessary for our tax returns.

Automated decision-making

How long we store personal data

We will share your information with our Debt Recovery/Tracing/Field Agents/Solicitors if you fail to pay any monies due to our company. C. View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by C. In order to ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We'll react as fast as possible, but within four weeks, at your request.
